In early 2023, the PSRA held regional face to face seminars for livestock marts to assist and support them in their understanding of their statutory obligations under the Property Services (Regulation) Act 2011 and Client Moneys Regulations 2012. These were very well attended and engagement between both parties was positive.

In September, the Authority published its Strategic Plan 2023-2026, detailing its strategic goals and objectives for the next three years. The Plan sets out the four goals that the PSRA will focus on over the next three years and will consolidate and build upon the achievements of the Authority's previous Strategic Plans. #### Licensee Client Account Reminder

Licensees are reminded that:

- <u>all</u> client accounts held must be identified and reported in the Accountants Report at time of licence renewal,
- personal or office expenditure cannot be discharged from the client account.

#### Licensees should note that:

- "Client Account" is a current or deposit account in the name of a licensee and in the title of which the word
   "client" appears.
- "Accounting Records" are the books of accounts and all other documents required to be maintained and kept by a licensee which can be in writing, electronic or another format.
- The "Minimum Accounting Records" to be held by a licensee include a cash book, office and client ledgers, a
  record of bank lodgements, a bank account register, client file, statement of fees and outlays and a copy of
  each balancing statement.

## Awareness Campaigns

During 2023, the Authority organised media information campaigns on national, urban and local radio stations as well as online and print advertisements to raise awareness of the PSRA and its functions.

These campaigns focused on the importance of using a licensed Property Services Provider and the consumer protection afforded to individuals when they do so.

The Authority will continue to promote public awareness of the role and function of the PSRA in 2024.



## Webinar: Multi-Unit Developments – Regulation of Property Management Agents

The Housing Agency and the Property Services Regulatory Authority (PSRA) will present a lunchtime webinar in February 2024. This webinar will provide an overview of the regulation of property management agents engaged by owners' management companies of multi-unit developments such as apartments.

Maeve Hogan, Chief Executive Officer of the PSRA, will discuss the Authority's regulatory role as it applies to property management agents, consumer protections, governing legislation, and related matters.

This webinar will be of interest to those involved in multi-unit developments, including directors of owners' management companies, property management professionals, residents, Approved Housing Bodies, and Local Authorities.

## Completion of 2023 PSRA CPD: Final Reminder

All licensees are obliged to complete five hours of PSRA accredited CPD annually which is delivered by IPAV and SCSI. The deadline for completion of PSRA CPD for this year is 31st December, 2023, <u>regardless of when your licence renewal date is</u>. There will be no extensions to this date and PSRA CPD cannot be completed retrospectively.

All five hours can be completed online and both providers offer a range of on-demand modules that can be undertaken at a time that is convenient for you.

Non-completion of PSRA CPD is a breach of Section 81 of the Property Services (Regulation) Act 2011 and may result in a sanction being imposed where the obligation to complete PSRA CPD has not been fulfilled.

## A Message from the Private Security Authority

If you are engaging a locksmith, your provider must be licensed by the Private Security Authority (PSA) even if their primary business is not locksmithing.

Property and Facilities Management Companies, Maintenance Companies and others providing locksmith services must be licensed. Using unlicensed providers puts your business at risk as you could:

Face Prosecution;

Invalidate your insurance cover;

Compromise the safety of your staff, tenants and clients;

Jeopardise the security of the premises.

If your business is providing locksmith services to others you must hold a PSA licence.

Check the PSA licence register for a licensed locksmith at www.psa-gov.ie

The following services are licensed by the Private Security Authority and can only be carried out by licensed contractors:

- Alarm and CCTV Monitoring
- Alarm and CCTV Installation/Maintenance
- Access Control Installation/Maintenance
- Cash In Transit
- Door Supervisor
- Enforcement Guard
- Event Security
- Locksmith
- Private Investigator
- Powered Gate Installation/Maintenance
- Security Guarding
